XVALUATION IN GST: Valuation principles in GST & Related person concepts in valuation

*E* **<b>REGISTRATION:** Procedure, exemptions, Multiple business, Multiple locations.

**TAX INVOICE, DEBIT & CREDIT Notes:** Tax Invoices, Bill and supply, Receipt Voucher, Payment Vouchers, Refund voucher, Issue of Revised Tax Invoices.

**ACCOUNTS-RECORD, RETURNS & PAYMENT OF TAX:** Maintenance of records, electronic ledgers for credit/liability / Cash, GSTN platform/portal, Monthly /Annual Returns; Matching of Financials with Returns

**ASSESSMENT-AUDITS:** Type of assessments, scrutiny of records, Regular/Special audits, Exports & Refund & General Refund procedures. Appeal procedures & Advance Rulings; Anti Profiteering provisions in GST.
