Institutional Members and Associate Members are not eligible to contest elections. The proposer and seconder for each nomination must also be current members with up-to-date subscriptions. RELEVANT EXTRACTS FROM THE BYE-LAWS

Clause 21

Institutional and Associate Members shall not be entitled to contest any elections. The minimum age for election shall be 30 years as of the date of nomination, and the candidate must have completed a minimum of two years of membership with the Institute.

Clause 22

A Member whose subscription is in arrears as of 30th June shall not be entitled to file a nomination or contest elections. Such a member shall also not be entitled to vote, propose, or second any candidature. If any such member is elected, the election shall be deemed null and void.

Clause 28

Voting Rights: Fellow Members, Members, Life Members, Life Fellow Members, and one representative of each Institutional Member shall be entitled to vote. Honorary and Associate Members are not entitled to vote.

Clause 61

The election of Members to the Branch Committee—consisting of Office Bearers, NC Members, and EC Members—shall take place at the AGM of the Branch for a tenure of two years.

Clause 62

Nominations shall be submitted on the prescribed form issued by the respective Branch Committee. Any Member who has served as an Office Bearer for a term of two years shall generally not be nominated for the same position again.

Self-nominations shall not be accepted. Each nomination must be proposed and seconded. The nominee, proposer, and seconder must be Members of the Institute whose subscriptions are not in arrears.

A nomination form shall be considered invalid if the number of nominations made thereon exceeds the number of available seats.
